- Tour participants must be at least 11 years old or in 6th grade.
- Participants over 18 years of age (including teachers and chaperones) must present a current photo ID.
- *For school grades 6-7, we require one chaperone per 5 students. For grades 8 and up, we require one chaperone per 8 students.*

Note: School/Group tours are offered April through October. Please submit the Tour Request Form up to three months to two weeks in advance (i.e. if you request a tour for April, please send us the tour request form no earlier than January.)

TREATMENT PLANT TOUR GUIDELINES

- **DRESS CODE - No shorts, short skirts, flip-flops, sandals or open-toed shoes.** Long pants and closed toed shoes are required. *If you are not wearing the appropriate attire you may be prohibited from taking the tour.*
- All visitors must be at least 9 years old or in the 4th grade.
- Never touch any switches, buttons or equipment. Watch your step!
- Keep your hard hat on at all times. You will be issued one for the tour.
- Always follow the directions of the tour guides.
- Feel free to take pictures, but stay with the group to avoid being left behind!
- Be mindful of the people working throughout the plant. Treatment plants are in operation 24 hours per day.
