FULLY CERTIFIED SOLAR INSTALLER LISTS

The GoSolarSF program offers incentives to San Francisco residents, businesses, and nonprofit organizations who install solar electric systems on their properties. In order for property owners to receive GoSolarSF incentives, they are required to use a GoSolarSF Certified Contractor.

To become a GoSolarSF Certified Contractor, Contractors are required to work in good faith with the City's Office of Economic and Workforce Development (OEWD) to employ San Francisco residents in 50% of all new hiring opportunities. Contractors must provide CityBuild with a list of Core Employees, and must notify CityBuild of all new hiring opportunities.
